  - During School Year (Quarterly Reporting)
    - Schools: Sector Specific
    - District, Sector, State: All Students Ever Enrolled Truant / All Students Ever Enrolled
  - End of Year
    - All Students Ever Enrolled Truant / All Students Ever Enrolled

# Act: Legislative Update

# Legislative Update

- *To clarify agency responsibilities with regard to school attendance*

## Legislative Update

- *To require educational institutions to obtain an explanation from a student's parent or guardian verifying the reason for an absence within no more than five days after a student's return to school*

# Legislative Update

- *To clarify attendance reporting requirements for local education agencies, independent, private, and parochial schools*

# Legislative Update

- *To repeal D.C. Official Code § 38-204 and 38-205*

## Legislative Update

- *To amend the protocol for law enforcement officers who come in contact with a minor and has reasonable grounds to believe, based on the child's age and other factors, that a child is truant*

## Legislative Update

- *To amend the educational institution referral requirement for Child and Family Services Administration, the Court Social Services Division of the Superior Court of the District of Columbia, and the Office of the Attorney General Juvenile Section to only include unexcused full day absences with regard to attendance*

## Legislative Update

- *To provide educational institutions with discretion on referrals if a student's 10<sup>th</sup> or 15<sup>th</sup> unexcused absence is accrued within the final 10 days of the school year*

## Legislative Update

- *To require the State Superintendent of Education to provide written notice to each local education agency, independent, private, or parochial school outlining the attendance and reporting requirements by August 1 of each year*
