


DCPS Year over Year Q1 Truancy Rate by Ward

■Q1 14-15 ■Q1 15-16




Compared to last year, DCPS had lower truancy rates for all Wards except for Ward 1. DCPS students in Ward 7 saw the biggest improvement in truancy rates with a decrease of 3.5% from the same period last year.






Compared to last year, PCS had lower truancy rates for Wards 2,5,6,7 and 8, and higher truancy rates for Wards 1 and 4. Students in Ward 7 saw the biggest improvement in truancy rates with a decrease of 1.1% from the same period last year.





DCPS had lower truancy rates for all grades compared to the same period last year. Students in grade 9 saw the biggest improvement in truancy rates with a 9.8% decrease.





PCS had lower truancy rates for grades 3, 9, 10, 11, and 12, but higher truancy rates for all other grades compared to data for the same period last year. Students in grade 9 saw the biggest improvement in truancy rates with a 1% decrease.
